

## DIRECTIONS TO TRIAL SITE:

### Westbound on Hwy #1

Take exit #160 that says "Laidlaw, Hunter Creek, Rest Area", go under the freeway to the second stop sign and turn right. You are now running parallel with the freeway heading towards Chilliwack. Go about 4 km, turn left at McKay Rd.

### Eastbound on Hwy #1

Take exit #153 that says "Jones Lake, Laidlaw". The exit veers to the right. You are parallel with the freeway, still heading towards Hope. Go about 2 km, turn right on McKay Rd.

**Input address: 58428 McKay Road - tell your GPS to search all cities in BC - if it offers you Fraser Valley - choose that. The Garmin did not find it in Hope, or in Laidlaw - but found it in Fraser Valley, British Columbia!**
