GENERAL INFORMATION

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Event Plan – You will be assigned a timeslot. In that timeslot you will complete all 3 components. There will be a limited number of people onsite to comply with the City of Ottawa /provincial COVID rules. We will monitor where you are travelling from to ensure compliance with travel/vaccine restrictions. (if applicable at time of trial)

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. *See below for TCN numbers. A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, in the opinion of the judge; they display no signs of physical discomfort and can safely complete the search.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered – Instinct and Novice, Open, Excellent and Master (Containers, Interior). Limited class entries. Exhibitors CANNOT compete in the same component at the same level with multiple dogs. **NO** move ups will be permitted between components.

NOTE: Instinct is an entry on its own or can be <u>combined with Novice only</u>. It cannot be combined with Open, Excellent or Master levels.

Scent Detection Prize List - Flat ribbons will be given for all qualifying scores. Rosettes for titles will be available, the day of the trial or shortly thereafter, depending on number of titles earned.

Penalties issued by club - Dropping food while rewarding is considered a contamination. Contamination of the search area will result in a non-qualifying score and any dog that does urinate, defecate or vomit within the search area will be excused from the competition and a monetary penalty may be enforced in either situation. Destruction of trial property (excessive scratching or subsequent breaking of an item) will have a monetary penalty of \$10.00 enforced.

Entry fees **All fees include H.S.T. and must be paid in Canadian Funds.

The CKC requires all owners of unregistered, recognized breeds entering events to obtain a <u>Temporary</u> <u>Competition Number</u> (TCN). TCNs will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

E toward **Cornwall.** Merge onto **HWY- 416 N** via **exit 721A** toward **Kemptville/Ottawa**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. Turn right on to Fourth Line Road and in 8 km you will reach the destination on right- 6361 Fourth Line Road.

From the East: HWY- 401

W toward **Kingston**. Merge onto **HWY-16 N** via **exit 721** toward **HWY-416 N/Kemptville/Ottawa/RTE-416 N**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. Turn right on to Fourth Line Road and in 8 km you will reach the destination on right - 6361 Fourth Line Road.

From the North: HWY 416

S toward **Prescott**. Take the Rogers Stevens exit # 49. Turn right (west) on to Roger Stevens Rd and drive 1 km. Turn right on to Fourth Line Road and in 5 km you will reach the destination on right - 6361 Fourth Line Road.
