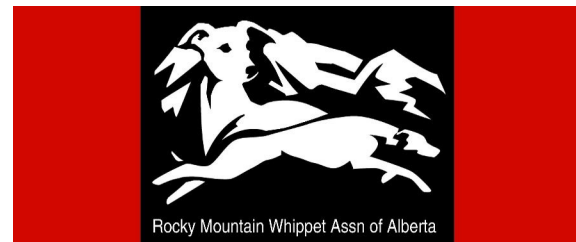

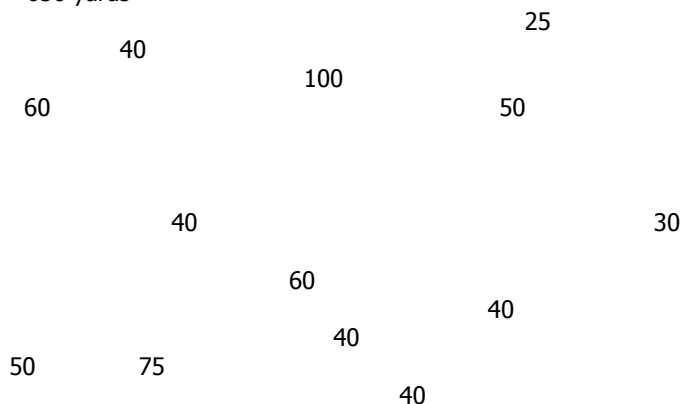


COURSE PLANS: Douglas Field Ponoka

For any Afghan Hound, Basenji, Borzoi, Scottish Deerhound, Greyhound, Ibizan Hound, [Italian Greyhound](#), Pharaoh Hound, Saluki, Whippet, or Irish Wolfhound that is one year of age or older on the date of the trial. All entrants must be registered with, or eligible for registration with, the Canadian Kennel Club. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible.

CHAMPIONSHIP POINTS:

IMPORTANT NOTICE:

CKC Non Member participation fee .

Canadian residents only Effective Jan 01 2011 the Canadian Kennel Club instituted a non member participation fee for all Canadian residents who Participate in a KC event , but are not CKC members. In order to protect titles/awards earned the non-member will have a choice. Either to be a CKC member or pay the Non member Participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non members who reside I Canada and does not apply to US exhibitors or CKC members or dogs co-owned with a CKC member

IMPORTANT NOTICE:

Effective July 1998, hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with their entry at the hound's first trial. Hounds with the following are exempt: ASFA F.Ch. or LCM, AKC F.Ch., S.C. or D.C. , but are still required to submit the Hound Certification form with their name and exempt title(s) circled.

ATTENTION US EXHIBITORS:

US owned dogs may compete with an Event Registration Number. This number must be obtained within 30 days of obtaining points, awards, or scores to avoid cancellation. An ERN can be obtained by submitting a copy of your AKC registration with a letter of request to the CKC offices. Fee is \$58.85(request may be faxed using VISA). An \$8.52 listing fee per trial is payable for each dog not showing a CKC or ERN registration number.

ADDITIONAL INFORMATION:

- Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.
- Bitches in season/lame hounds will have entry fee refunded provided notice is given at or before Roll Call.
- Dogs not present at Roll Call will be scratched and entry fee not refunded. No Exceptions.
- Hounds will be run twice, in braces or trios (unless dismissed, excused or disqualified.)
- All handlers must use a slip lead when releasing a hound. A Standing Start will be used on Tally-Ho.
- Leg wrappings must be of a neutral color to comply with CKC rules. Muzzles and catch collars may be used at the handler's discretion.
- Bring your own water and shade.
- No catalogue will be published. Score sheets will be available.
-
- Coursing entries received after the closing date will be charged the late/day of trial fee.
- \$5.00 will be levied against the owner/handler of any hound loose on the coursing field.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.
- A valid rabies certificate is required to bring a dog into Canada.
- Overnight camping is NOT permitted at the site.
- Washroom and food concession will be available.
- Please clean up after yourselves and your dogs. Do not stuff plastic bags down holes. Please use the trash receptacles provided.
- Please do not leave cigarette butts on the ground dispose of properly .

Coming from the North

Hwy 2 South to Matejka Rd (2nd overpass south of Ponoka)Onto overpass Turn left contunue to first Rd South Rqe Rd 263 (Left)Go 2 miles South to first intersection Twp 422. Make a left here. You will see mail boxes a sign Pleasant Hills , No Exit. Follow Rd around to the right to end of Cul de Sac. Field has 2 white gates to go through. CLOSE GATES SECURELY WHEN YOU ARE THROUGH.

Coming from the South:

Hwy 2 North pass Lacombe to Wolf Creek Golf/Iowolta Rd.Overpass Sec hwy 604 Go under overpass heading west to first North Rd 263 Go 2 miles North to twp 422. Turn right . You will see mailboxes and a sign Pleasant Hills, No Exit. Follow Rd to right to end of Cul de Sac Field has 2 white gates to go through CLOSE GATES SECURELY WHEN YOU ARE THROUGH
