CCN, ERN and PEN Numbers - The cost of obtaining a Canine Companion Number (CCN), Event Registration Number (ERN) or Performance Event Number (PEN) with the CKC has been increased to \$64.00 plus 5% GST Canadian funds.

BITCHES IN SEASON - Bitches in season are not permitted to compete. "When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial must reach the trial secretary on or before the date of the trial. The trial giving club must refund the entry fee, service charge and listing fee. The refund and the terms thereof must be clearly stated in the premium list.

- 3. The Trial Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability for, either dogs, exhibitors or patrons in the event of an accident or misfortune.
- 4. Dogs must be on the grounds one hour prior to the judging of their respective class.
- 5. The owner of a dog entered in these trials is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.
- 6. Exhibitors and handlers will be responsible for their dogs and equipment left at the show grounds.
- 7. Dogs are to be exercised in designated areas only, not in the show building.
- 8. If, because of civil disturbance or other acts beyond the control of the club, if it is impossible to open or complete the trials, there is no refund of entry.
- 9. Dogs must be on leash at all times on the grounds with the exception of the obedience and rally rings.
- 10. It shall be the duty and obligation of the trial giving club to see that a Judge, Club Official, Ring Steward, or Competitor at an Obedience or Rally Trial held under these regulation, is not subject to indignities of any kind.
