## ALL BREED HERDING TRIALS June 14, 15 & 16 2024

Thank you all for entering these trials and supporting herding in Alberta! We have just a few things to make you aware of prior to this weekend.

***Day of Trial Entries will be allowed! Move-ups are permitted.***

### Judging Counts and Schedule

#### **Friday June 14, 2024,**

General Briefing at **4.00 PM**

#### **Saturday June 15, 2024**

- General handler briefing to begin **no earlier than 11.00 a.m.** Trial 3 and 4 briefings to follow. Classes within the trials will be run one after the other. E.g. JHD 3 followed by JHD 4 etc..

#### **Sunday June 16, 2024**

- General handler briefing to begin at **8.30 a.m.** Trial 5 and 6 briefing to follow. Classes within the trials will be run one after the other. E.g. JHD 5 followed by JHD 6 etc..

Judging Counts are included. However, the final order may be adjusted by our judges. Counts could also be affected by Day of Trial Entries.

Please be at the trial site 30 minutes before the handler's meeting so that we can begin on time.

We have a very full schedule for these trials so **please be ready** when it is your turn to run. No dogs or spectators within 10 feet of the arena.

### Facility

Our host facility is a working farm. Please keep your dogs on leash at all times and stay away from animals, **INCLUDING GUARDIAN DOGS**, in the pasture. Keep your dogs crated when not being exercised or in the arena. We will have water and toilet facilities on site; please bring shade for yourself and your dogs. This is Alberta, so come prepared for ALL weather.
