## OUR JUDGES

**Kathrine Grant** - I am a retired hospital administrator, Manager of the Regional Trauma Program at a large teaching hospital in London, ON. I currently reside on Manitoulin Island in Lake Huron, the largest freshwater island in the world. I have been involved in the sport of purebred dogs since 1976. During that time I bred and showed Irish Setters and Smooth Fox Terriers. I bred Irish Setters under the Ballyboy prefix and Smooth Fox Terriers under both the Ballyboy prefix and Fauxpaw prefix (co-bred with Joe & Janet Lobb).

I owner handled my dogs most of the time with modest success - #2 Smooth Fox Terrier in Canada, with Group and BIS wins. I also owned and showed a Keeshond and Pointers. Currently share my life with a Pointer and a Miniature Wire-haired Dachshund. I have been judging since 1997, presently licensed for Sporting, Hounds, Terriers, Working and Herding breeds and currently on permit for the Non Sporting group. I am a member of the Canadian Dog Judges Association and was the founding secretary of that organization holding the position for almost 10 years; recently elected as a Director at large.

Some of my memorable judging assignments include the Ontario All Pointing Breed Specialty Show, Brittany Club of Canada Specialty Show, Chesapeake Bay Retriever Club of Canada Specialty Show, and Belgian Shepherd Dog Regional Specialty Show. I have judged internationally in Australia.

**Darle Heck**- Darle began her association in dogs as a member of the Regina Kennel and Obedience Club's junior handlers.

She started showing and grooming her parents Scotties as a child, winning her first group at age 12. She has shown and bred Scotties since then. She worked for a professional handler during her teens and at that time, she fell in love with Bouviers and arranged with some friends to bring 3 into Canada for showing and breeding purposes. These were some of the earliest Bouviers brought into Canada and many top winners came down from these lines. Since 1995, she has also

been breeding and showing Wire Fox terriers all under the Beinnein prefix. Beinnein Kennels has consistently produced dogs who have been Specialty winners, as well as dogs who have been nationally ranked at the top of their breed and their group in Canada and around the world.

Darle has been judging since 2000 and has had the honour of judging in Canada, the US, Australia, France, Hungary, Ireland, Italy, Malaysia, Poland, South Africa, Slovenia and New Zealand. She has judged several National specialties including the US National at Montgomery for Scottish Terriers.

Darle is also well known for her canine artwork, she has done illustrated guides for several breed clubs and limited edition prints in a number of breeds.

Darle is currently licensed as an all-breed judge by the Canadian Kennel Club.

**Karsten Kaemling**, of Vancouver, British Columbia, is a Life Member of the Canadian Kennel Club and has been a licensed CKC Judge since 1999. Karsten is approved to judge the Terrier, Toy, Herding, Hound, and Non-Sporting Groups and currently under Permit for the Working Group with the CKC.

Apart from his assignments in Canada he has also judged in Germany, New Zealand, Russia, Australia and Ireland.

Karsten has bred and exhibited the Airedale Terrier and the Sealyham Terrier, along with the Afghan Hound. He is also the pioneer of the Cesky Terrier in Canada, having imported the breed, launching the national breed club, and eventually achieving full recognition for the breed with the CKC in the year 2000.

Karsten has written many articles which have been published internationally and has also given numerous seminars at judge's education study groups. He has served on the Canadian Kennel Club Registration Committee, and is currently serving on the Canadian Kennel Club Discipline Committee as well as on the Legislation Committee. Karsten has also participated as a mentor and instructor at dog handling classes especially geared towards the novice exhibitor, and is himself a member of a judge's study group in B.C. When not busy with his kennel club activities Karsten is involved within his community as a Senior's Advocate in Vancouver's West End.

**Larry Kereluke** – Larry is a life member of the Canadian Kennel Club and is involved with several clubs and associations. He has served on several committees for the CKC, including the internal Discipline Committee. He was a member of the Education Committee for the Canadian Dog Judges Association, President of the Northwinds Dog Club, Past President of the Afghan Hound Club of Canada and an active member of the Manitoba Gazehound Association. Currently he is the Manitoba Director for the Canadian Kennel Club.

Larry started in the sport of pure-bred dogs with the purchase of an Afghan in 1967. He began to attend shows and soon was 'hooked'. Back in those days, many of the shows were benched. This proved to be a great learning experience.

As many others before him, Larry followed the natural progression and soon acquired an Afghan female to breed. Her only litter produced 9 Champions and began the Timang Afghans. From there he began his breeding program. When Larry bred his last litter in 1985, he had 50 Champions to his credit.

While attending shows with his Afghans, he would also handle dogs for clients. Larry was very fortunate to have some very good dogs to show along the way. Most of these dogs were in the Hound group and included Salukis, Irish Wolfhounds and Borzoi. He exhibited both in Canada and the United States for many years winning Best in Shows in both countries. In 1985, Larry entered the ranks of judging. He is approved to judge all breeds in Canada and the world. He has judged in many countries including Sweden, Denmark, South Africa, New Zealand, Australia, Argentina, Mexico, Brazil, Chili, the Philippines, Hong Kong and the United States

**Dr. Richard Meen** – Dr. Meen became actively involved with purebred dogs in 1965 and has bred and exhibited a number of breeds under his prefix Kishniga. His homebred Borzoi was top dog All Breeds in Canada in 1977, and he bred and co-owned the top Terrier in Canada in 2011 - a Skye Terrier.

Past President and Chairman of the Board of the Canadian Kennel Club, he is active in many dog organizations in Canada and the U.S., and judges all over the world. He recently had the honor to judge Best in Show at Westminster Kennel Club. He has also judged at Westminster on four other occasions, including the Terrier Group in 2007.

Dr. Meen practices psychiatry in Toronto.

**Judith Taylor** - I bred my first litter of Collies, in 1963. Thereafter, I have only bred Golden Retrievers and for a brief time with my husband at the time, Brian Taylor, a couple of litters of Irish Setters.

I have been breeding Golden's for most of my life, accumulating 53 years! As a professional all breed dog handler for 38 years, there are many breeds of dogs that I know and love and I do appreciate most breeds of dogs! In 1993 I was awarded Top Handler of the Year by the PHAC. Some of my favourite breeds to show were Rottweilers, German Shepherds, and Great Danes.

After achieving somewhat success in both conformation and now the "hunt test" titles with my Golden Retriever's, there is a renewed respect for 'form = function' and as a licensed "dog judge" I will certainly keep this in mind when I pass judgment on any dog that was bred for a purpose. A great deal of pleasure is achieved when I judge, this being in North America, China and Mexico.

**Dr. Terill Udenberg** has been involved in the sport of exhibiting dogs for nearly thirty years, starting with Dobermans. After a short hiatus, he returned with Standard Poodles and eventually included Toy Poodles. He has been breeding Standard Poodles for over twenty five years with the prefix "Tees" of Tees Blue Skies. He has had multiple Best In Show, and Best In Specialty winners including several top 10 dogs, but his love is exhibiting the young specimens of his breed.

Dr. Udenberg has judged in Canada, USA, and Australia and New Zealand many times, and frequently does seminars in many subjects including, "The Physics of Center of Gravity" in Conformation and Movement, Canine Reproduction, and in Brachycephalic Airway Syndrome. Most recently he gave seminars in both New Zealand and in Australia to the Dogs Judges associations, as their key note speaker.

He was a member of the Health Committee for the Pekingese Club of America. Dr. Udenberg was invited to speak at the National Pekingese Club of Great Britain (on airway research), and as expert witness regarding changing the Pekingese Standard which is owned by the Kennel Club of Great Britain. The research included other breeds in the Brachycephalic group. He has had the honor of judging many specialties in both the USA, Canada, and Australia, including Tibetan Terriers, Poodles, Boston Terriers, Pekingese, Pomeranians, Miniature Pinschers, Lowchen, Australian shepherds and others.

He is an avid Veterinary volunteer in world disasters including Katrina, Guyana, Peru earthquakes, and several in spay and neuter programs in Fiji. Dr. Udenberg, as a Veterinarian, has special interest in genetically inherited diseases, as well as, special interest in critical care including Cardiology, Ultrasound, and Acupuncture. He is an avid outdoors man including biking, hiking, kayaking and extensive travel for scuba diving along throughout the world. He is currently approved for all of group 1,3,5,6 and on permit for all of group 7.

**CHAMPIONS AND CHAMPIONSHIP POINTS**

A dog awarded WINNERS at a Championship show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded WINNERS shall be as provided hereunder. The schedule to be employed in the determination of the number of points awarded WINNERS shall be as follows:

Competing*	1	2	3-5	6-9	10-12	13 or more
Points	0	1	2	3	4	5

\*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for points. If a dog awarded WINNERS is also awarded BEST OF BREED at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total. If a dog awarded WINNERS is also awarded BEST OF OPPOSITE SEX to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total. If a dog is awarded WINNERS is also awarded BEST OF WINNERS, then all dogs defeated directly or indirectly in the breed shall be included in the total. If a dog is awarded WINNERS only, then all the dogs of the same sex in the class competition shall be included the total. The number of championship points to be credited to a dog awarded WINNERS shall be determined by the highest award earned and calculated as per Section 15.1. In addition to championship points allocated at the breed level, a dog awarded WINNERS, which also places in the regular Group competition, shall be credited with the following additional points provided that a dog was defeated at the Group level.

A dog awarded WINNERS which also places BEST IN SHOW at an All-Breed Championship Show shall be credited with 5 Championship points inclusive of any points earned at the breed and group level. In no case can a dog earn more than five points at a single show.

An error in the class, date of birth or sex may be amended on the entry form up to one hour BEFORE the start of the show.

### **SHOW RULES AND GENERAL INFORMATION**

1. Showing correct information on entry forms is the responsibility of the entrant. The show committee reserves the right to refuse any entry subject to CKC rules. Entry forms must be the same size and format as those included or they will be rejected.
2. No entry will be accepted unless accompanied by entry fees. Telephone entries WILL NOT be accepted. Email and Fax entries will be accepted. See instructions elsewhere in this premium list.
3. Post-dated cheques ARE NOT accepted. Tendering of an N.S.F. cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. **A \$25.00 SERVICE CHARGE WILL BE LEVIED ON ALL N.S.F. CHEQUES AND INVALID OR DECLINED CREDIT CARDS.**
4. Entry fees WILL NOT be refunded in the event that a dog is absent, sick, lame, excused by the veterinarian or judge, in season or barred from competition because it has been entered incorrectly.
5. Withdrawal of entries prior to closing date may be made by telephone, but **MUST BE FOLLOWED UP IN WRITING** to the Show Secretary so as to be received no more than 7 days after closing.
6. The entry of any dog cannot be altered or canceled after entries close, except as provided in the Dog Show Rules.
7. After the closing of entries, an identification/receipt and judging schedule will be mailed or emailed to each exhibitor or agent. Owners making entries please include agent's address. All online and fax entries will receive a conformation email, this is your receipt for our shows. Please print your email address clearly.
8. ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES.
9. The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for or assume any liability in the event of an accident or other misfortune to either dog, exhibitor or patron. The Show Giving Club will not be liable for any loss or injury that may be sustained through the disappearance, loss, theft, and/or death of dogs entered in the show under any circumstances.
10. If, because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.
11. EXHIBITORS PLEASE NOTE: Chapter 24, Section 6, C.K.C. Dog Show Rules states "Any person participating in any capacity at a dog show held under these Rules shall not be subjected to indignity of any kind during the progress of the show and it shall be the duty and the obligation of the Club holding the show to see that this rule is effectively carried out."
12. ACCORDING TO CITY BYLAW, DOGS ARE NOT ALLOWED OFF LEAD WITHIN CITY LIMITS. Exercise dogs only in designated areas. **Anyone not following stop and scoop policy will be excused from the shows and trials.**

#### ***Non-Member Participation Fee***

##### **24-12-3. Non-member participation fee**

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled.
