- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot move up to the next level.
- d) The fee only applies to dog wholly owned by non-member residents.

Eligibility: To be eligible to compete in an agility trial, the dog must be registered with the CKC, be eligible for registration with the CKC, have an ERN, or have a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

**Bitches in Season** are not permitted to compete. The judge of an agility trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.

## **Agility Rules & Regulations**

4.1.3: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
