Bitches in season, dogs with injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans may not participate.

The person who signs this agreement represents that he/she ("I") is authorized to enter into this agreement. I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner of the dog entered hereon. In consideration of the acceptance of this entry, I/we ("I") have read and understand and will abide by the Official Rules and Regulations of the Canadian Association of Rally Obedience (CARO) in the effect at the time of this entry, and by any additional rules and regulations set out by the Nicola Valley Dog Enthusiasts Association. I certify and represent that the dog entered is not a hazard to persons or other dogs.

I agree that the Nicola Valley Dog Enthusiasts Association has the right to refuse this entry for cause, which the organization shall deem to be sufficient. In consideration of the acceptance of this entry and of hosting of this event and of the opportunity to have the dog participate or be judged, I agree to hold the organization, its members, officers and directors, CARO, and its officers and directors, sponsors of the event, owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the premises or grounds or near any entrance thereto, and I personally assume all responsibility and liability for any such claim; and I further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

This event is being held on a working ranch. We need to do our utmost to avoid disturbing the ranch animals, so dogs may not be off-leash outside or in the parking lot. Dogs must be in a closed pen or crate or on a leash at all times. The only exception is when the dog is working on a course, they may be offlead. Please do not set up your pen in the parking lot or allow your dog to be noisy outside the arena.

I have read, understand, acknowledge and agree to abide by the above Agreement, & understand that I am fully and completely responsible for the behavior of my dog(s) attending this event whether entered or not.
