NON-MEMBER PARTICIPATION FEE

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

NO POST DATED CHEQUES ACCEPTED. ALL NSF cheques are subject to a charge of **\$25.00**. N.S.F. cheques are considered **Non-Payment of entry fees** and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the shows/trials.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable In Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

INCOMPLETE ENTRIES WILL BE RETURNED. Agents and handlers please note that the **full name and address of owners MUST be filled in** and to whom ID's are to be returned. (Section 13.1.2 Dog Show Rules)

CONFORMATION CLASSES

- Junior Puppy A dog 6 months up to 9 months on the day of the show.
- Senior Puppy A dog 9 months and up to 12 months on the day of the show.
- 12-18 Months A dog between 12 months and up to 18 months on the day of the show.
- Canadian Bred A which was born in Canada.
- Bred by Exhibitor A dog owned and handled by the breeder.

- Open Class A dog 6 months of age or older
- Specials Only Dogs who are Canadian Champions.
- Altered Dog Class Dogs who have been neutered or spayed by Veterinarian. Class divided by sex only not by age.
- Exhibition Only Dogs 6 months of age and over not in competition. Dogs 3 months of Age and under 6 months on the day of the show may be entered in Exhibition Only providing that the owner of the puppies has also entered a dog in one of the Regular official classes. No exhibitor may enter more than 2 puppies.

Champion & Championship Points ~ Chapter 1 Section 1 ~ A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of Championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show.

OBEDIENCE CLASSES

Novice A & B, Open A & B, Utility (Pre Novice, Novice C & Novice Intermediate) SEPARATE ENTRIES ARE REQUIRED FOR EACH CLASS ENTERED ~ State Jump Height

- Pre-Novice for all purebred dogs over 6 months of age (Not eligible for HIT Competition)
- "A" Classes for dogs handled by owner or immediate family member through all exercises
- "B" Classes for trainers, multiple entries, exhibitors who have attained a Cdn OTCH, degree or dogs who have earned titles in another country
- "C" Class for dogs who have completed a CD title in Canada (Not eligible for HIT Competition)
- C.D.I. Novice-Intermediate, for dogs who have earned a CD title in Canada (Not Eligible for HIT Competition)
- Open for dogs who have earned a CD in Canada
- Utility for dogs who have earned a CDX in Canada
- Exhibition Only dogs 6 months and over, not in competition

RALLY OBEDIENCE CLASSES

Exhibitors entering both obedience and Rally must fill out separate entry forms

- Novice A for dogs that have not earned the RN title or a CD or higher and is handled by the owner or immediate family
- Novice B for any dog until such time as a qualifying score in Advanced is earned
- Advanced A for dogs that have earned the RN title but not earned the RA title and is handled by the owner or immediate family member
- Advanced B for any dog that has earned the RN title

Excellent A for dogs that have earned the RA title but not earned the RE title and is handled by the owner or immediate family member

Excellent B for any dog that has earned the RA title

Bitches coming into season MAY NOT compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary receives a Veterinarian's Certificate PRIOR to the commencement of the Trial.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require and Events Registration Number (ERN). To obtain an ERN simply do the following:

1. send a photocopy of the dog's Registration Certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide the CKC with your full return address to enable the ERN to be sent to you
4. Faxed requests will be accepted. Please indicate your VISA/MasterCard number and expiry date, the card holders name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores.

3. To comply with CITY OF MONCTON regulations **NO SMOKING WILL BE PERMITTED WITHIN THE CONFINES OF THE BUILDING.**
4. Dogs should be on standby at their respective areas 30 minutes prior to commencement of judging. Judges are not required to wait for late arrivals and will adhere as closely as possible
