DATE: Sunday May 1st 2016 4 TD 2 TDX ACCEPTANCE DATE: 9 a.m. Monday March 15th 2016
Entries received prior to this time will be returned. ENTRIES CLOSE: 5 p.m. Monday April 15th 2016 or
automatically when limit reached.

A listing fee of \$9.61 as established by The Canadian Kennel Club must accompany the entry of a dog if
a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown
on the entry form.

All cheques or money orders are payable to Weimaraner Association of Canada

In accordance with the CKC's Tracking Test Rules and Regulations section 2.2.4 Option #2, priority will be
given to Weimaraners as follows: (1) Specialty breed without title (2) Other breeds without a title (3)
Specialty breed with a title (4) Other breeds with a title.

U.S. Exhibitors - To pay in Canadian funds, use Postal Money Orders or the equivalent made out in
Canadian dollars. Personal cheques will be accepted only if payable in U.S. funds for the full amount of
the entry. Personally discounted cheques will not be honoured. Please do not mark personal cheques
"Payable in Canadian funds" or "At par" as such items are not readily cleared through the banks. Thank
You.

As per CKC rules (6.1.19), we are accepting entries through CANADA POST ONLY with ONE ENTRY PER ENVELOPE. Absolutely no exceptions. Please make sure NO SIGNATURE IS REQUESTED on entries sent via Express Post.

All entrants will be notified by email or phone (if no email address is provided) when their entry has been received. Once the advertised limit has been reached, all remaining entries will be placed on the alternate list.

Refunds - Entry fees for dogs NOT entered in the Test will be refunded within 10 days of the tracking test. If a dog is withdrawn after the closing date, refunds will only be given if their place is taken by an alternate.

Bitches in season will be allowed to compete and will run last. Pinch or prong collars are not allowed on the Test grounds.

Rendezvous and track draw- Scheduled for 8:00 a.m. Sunday May 1st at Directions: Track site #13222 Rd 29, Warkworth, ON K0K 3K0 44.161383,-77.942445

401 from T.O take Exit 474 in Cobourg and head N. on County Rd 45

Turn right (East) onto County Rd 29.

Turn right at first stop sign and turn left at 2nd stop sign. Go to #13222 house on left.

401 from Kingston take Exit 509 and head N on County Rd 30.

Turn left (West) onto County Rd 29. Go through town of Warkworth.

Keep on County Rd 29 to #13222, house on right.

From Ottawa VIA HWY 7.

In Havelock turn left (south) onto County Rd 30.

Turn right (west) onto County Rd 35, go to end.

Turn left (south) onto County Rd 25.

Turn right (west) onto County Rd 29 to #13222, house on right.

From Peterborough VIA HWY 7.

Turn right (south) onto County Rd 38.

Turn left (west) onto County Rd 2 to town of Hastings. Turn right onto Bridge St Go through Hastings. Turn left onto County Rd 25. Turn right (west) onto County Rd 29 to #13222, house on right.

Confirmation of entry and directions to rendezvous point will be forwarded to each competitor upon receipt of entry.

Successful dogs - All exhibitors receiving a "pass" will be awarded a Rosette.

Discipline Regulation: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. Non-member participation fee – Effective January 1, 2011 a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
