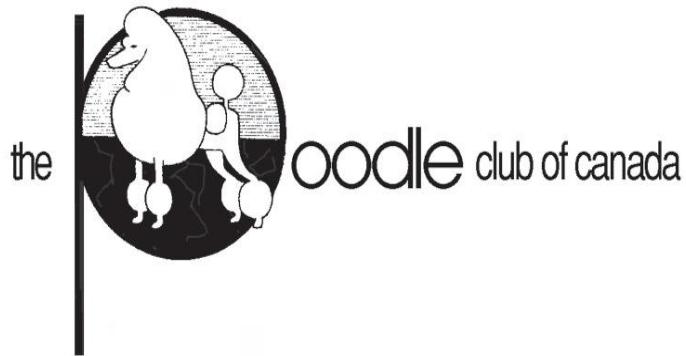

**Cheques dated after close of entries will not be accepted and NSF cheques will be considered non payment of entry and the handlers will not be entered in the tests. The owner of a dog entered in this event is entirely responsible for any error in entering the dog, regardless of how, or by whom the entry is made.**

**Attention Foreign Exhibitors**

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

**14.7** It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

## **Entry Information**

Entries will be run by the order in which they are received. Dogs owned or handled by the same person shall be separated in the running order, if possible.

Pigeons and/or game birds will be used on land. Ducks will be used in water.

Handlers and spectators shall not wear white or light clothing at any time, but handlers may wear white jackets for the blinds in the WCX.

Bitches in season may not compete in WC tests. Refunds will be given upon receipt of a veterinarian certificate prior to the test.

Rosettes will be awarded to all qualifying dogs.

Separate entry forms must be completed for each dog and each test entered.

The Poodle Club of Canada, its members and the land owners will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or spectators.

### **Non CKC member participation fee**

a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

b) In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

c) The Premium List must carry a note stating that these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members. The Non-Member Participation Fee is effective January 1, 2011.
