Section 14.7 of the Working Certificate Rule Book "It shall be the duty and obligation of the event giving Club to see that a Judge. Club Official or any participant at an Event held under these Rules is not subject to any indignities.

Order of running: Tests will be run at the "causeway".
Order of tests: WC's land and water, WCI's land and water, WCX land and water. (This may be changed by the judges).

Entry Fee: \$45.00 includes HST
Entry fee is in Canadian Funds please. No exchange will be given on US funds. A \$11.30 (includes HST) listing Fee must accompany the entry of any dog for which an individual CKC registration or ERN number is not shown.

All owners of unregistered, CKC-recognized breeds entering events are required to obtain a *Temporary Competition Number* (TCN).

TCNs are replacing the current system of entering events with dogs as “listed”, and allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

- A TCN must be obtained before submitting an entry for an event.
- The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.

A TCN cannot be used for Listed Breeds with an MCN (Miscellaneous Competition Number) or dogs that will require a PEN (Performance Event Number) or CCN (Canine Companion Number).

TCNs can be obtained:

- [Online](#) through CKC’s Portal (Note: Individuals who have not yet used the online Portal will be required to create a Portal account before they can submit a TCN application online);
- By submitting a completed [paper application](#) by mail to CKC; or By contacting the Shows and Trials Division Toll Free at 1-855-364-7252.

If the test fills and you wish to go on a wait list a paper entry may be mailed to the test secretary and a list will be compiled on a first come basis. No paper or emailed entries will be accepted prior to the opening or the filling of the test.

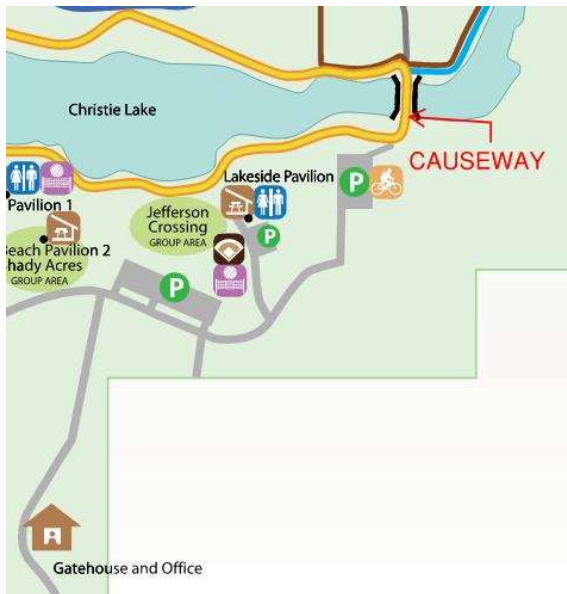

Test Grounds: Please no littering. Please pick up after your dog. Dogs should be on lead unless running the test as per park rules.

Clothing: Camo or dark clothing. White jackets for blinds in WCX.

ducks on land and ducks in water will be used in all tests. Standard CKC Rosettes will be awarded to all passing dogs.

Headquarters: The Headquarters will be at the "Causeway" enter Christie Lake Conservation Area and go down the road to the stop sign. Turn right and keep on that road to the test area.



Food: Will not be available due to COVID restrictions

Gate Fee: Exhibitors will have to pay \$15.50 on entering the park.

Directions: To Christie lake Conservation Area:

From Toronto Area: QEW to Hamilton take the 403 Hamilton Exit 74 for HWY 6 North to Guelph. Turn left onto HWY 5 Christie Lake Conservation is 9 km down on the left-hand side

From Hamilton: 403 East Exit 74 for HWY 6 North Guelph. Turn Left onto HWY 5, Christie lake is 9 km down on the left-hand side.

From London Area: 401 East towards Toronto. Take 403 Hamilton Exit 74 for HWY 6 N to Guelph Drive south on HWY 6 to Hwy 5 (Clappison Corners) and turn right and follow Hwy 5, 9km to Conservation area.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19
