Please bring your exhibitor's ticket or know your armband number to pick up armbands before trialing.

Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.

Rally Obedience Judging is based on 15 dogs/hour plus a 10 min walk-through time per class.

Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies.

It is the exhibitor's responsibility to know the rules pertaining to the trials.

The precincts of the Trials will be the building and its surroundings.

No prong or spike collars permitted on site.

All exhibitors will be responsible for the clean-up of their own dogs anywhere on the trial site and surrounding areas.

Due to the large number of entries for our Rally Trials, we are now in an "overload" position, and have had to acquire a second judge, Louise Weaver, to judge this overload. However, all qualifying scores are to be considered as given by the advertised judge, Karen Macfarlane. The classes to be judged by Louise Weaver are: Rally Intermediate and Rally Advanced A and B for both trials. Only those exhibitors who have a conflict with this change shall be permitted to withdraw such entries at any time prior to the day of the trial and the entry fees and listing fees paid for entering such dogs shall be refunded.

The Venue will be open at 8:00 am on Saturday and Sunday.

Please be advised that there will be crating in the room adjacent to the Trialing area. Only those exhibitors whose class is currently competing (including time for walk-throughs for Rally) will be permitted to stay in the crating area. We ask that as soon as your class is completed, you vacate the crating area to allow the following class exhibitors to set up their crates. As Trial 2 will be held in the afternoon, you may leave your crates.
