From Vancouver: (76 KM)

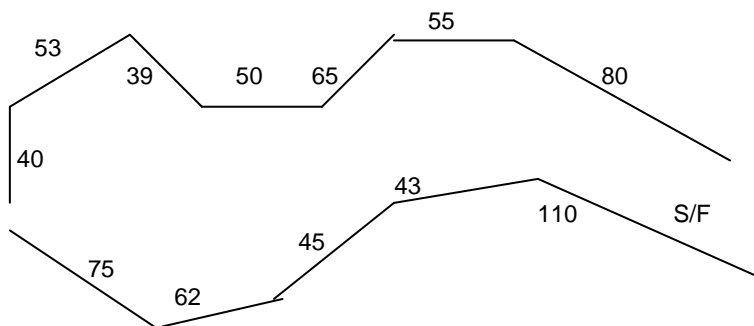
- Take Trans-Canada Hwy (Partial Toll Road)

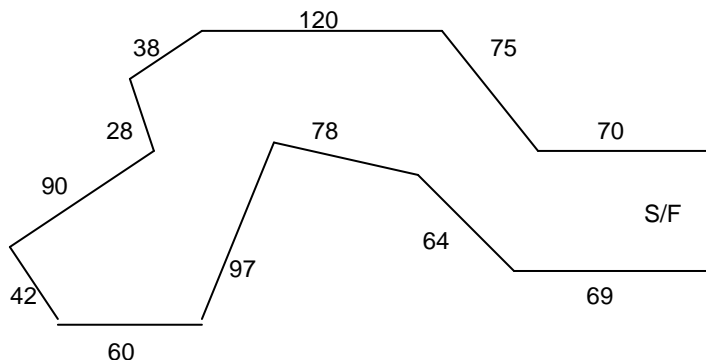

**ELIGIBLE ENTRY: Field Trial**

For any Afghan Hound, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Pharaoh Hound, Saluki, Scottish Deerhound or Whippet that is one year of age or older on the date of the trial. All entrants must be registered with, or eligible for registration with, the Canadian Kennel Club. Hounds with breed disqualifications, altered or neutered are eligible. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible for the Open Stake, but are allowed to run in the Singles Stake.

**STAKES:**

**Open** all hounds, including Field Champions  
**Mixed** for multiple breeds with entries of three or less, with the owners' agreement  
**Best in Field** for all Best of Breed winners & 1st place Mixed Stake winner, both Sat and Sun. Run on Sunday only. **This stake is offered only by decision on the day and will be made by the Field Trial Committee.** At least two hounds must offer and sizes must be compatible

**Miscellaneous Events:**

**Singles** for any hound, at least 12 months old, not entered in the official trial. No championship points are awarded. Run individually, once, on a full course. (6 hound limit)  
**Puppy** Hounds, 6 to 18 months, not entered in other the official trial of the day. No points awarded. Run individually, once, shortened course.

**EQUIPMENT:** Battery powered drag line lure machine with white plastic streamers.

**PRIZES:** Flat Ribbons will be offered for all awards.

**ADDITIONAL INFORMATION:**

**Order of running:** Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.

- The owner of the facility requests all competitors or spectators not to bring a bitch in season onto the grounds. Please respect this for the sake of all entered males. Please check your bitches before leaving home.
- Entry fee for all bitches in season and lame hounds will be refunded .provided notice is given at or before Roll Call.
- Hounds not present at Roll Call will be scratched and entry fee not refunded.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has happened.
- Only the 1st place winner of the Mixed Stake may compete in Best in Field.
- A \$5.00 fine will be levied against the owner of any hound loose on the field.
- For your comfort, please wear appropriate footwear.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.
- A valid rabies certificate is required to bring a dog into Canada.
- Toilet facilities are available in the park.
- There will be a food concession at this event. The Blackberry Kitchen will be open 9:00 am to 4:00 pm each day.
- This location is a public park, and they have strict rules regarding dogs in the park. Unless the dogs are running the course, all dogs must be on leash or confined to a pen or crate. You must clean-up after your dog. Failure to do so may result in your being asked to leave the park. Please properly dispose of trash (e.g. cigarette butts, dog poop), as this is an public park.
- There will be a walking start. Do not release your dog before the 'T' in 'Tally-ho', or else the dog may be assessed a penalty of between 1 and 10 points for that run by each judge.

**IMPORTANT NOTICE: (This does NOT apply to Singles entries.)**

Effective July 1998, hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with the entry at the hound's first trial. Hounds with the following are exempt; ASFA F.Ch. or LCM, AKC QS, S.C. or D.C., but are still required to submit the Hound Certification form with their name and exempt title(s) circled.
