

## PRIZES

Suitable prizes will be offered for highest scores in Rally Novice Class A, B, and C Rally Advanced A, B, C and Rally Excellent A, B, C.

## RIBBONS

Awards in each class will be based solely on the number of points earned, with the exception of ties. There are no awards for competition between classes.

Each dog that receives a qualifying score in Rally will receive a ribbon or rosette indicating "Qualifying Score". Qualifying scores for Class C will also be provided with a qualifying certificate.

A "High in Class" rosette, identifying the class, shall be provided for each class. Rosettes will be offered for 2nd, 3rd, and 4th place.

## RESULTS

Results for Rally Class C will be stored by the Show Secretary and provided to the exhibitor upon request to be supplied to another CKC Sponsored Rally Trial as proof of qualifying score towards completion of a title.

## TITLES

Dogs receiving three qualifying scores under two judges will be able to move up to the next class and have the initials R.N, R.A or R.E. or dogs under the PAL program; R.N (Pal), R.A (Pal) & R.E (Pal) placed after their names.

## ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. ## RULES

A copy of the Rules pertaining to Obedience Trials is available from the Canadian Kennel Club. It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

ATTENTION FOREIGN EXHIBITORS PLEASE NOTE that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian funds" or "At par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

## CATALOGUES

On a pre-order basis only, please remit \$8.00 per catalogue with entries. Catalogues will not be mailed to exhibitors who are absent.

## RALLY OBEDIENCE CLASSES

**Novice A** for dogs that have not earned the RN title or a CD or higher and is handled by the owner or immediate family member

**Novice B** For any dog until such time as a qualifying score in Advanced is earned.

**Novice C** For any dog not registered with the CKC but has a Purebred Alternative Login number (PAL Number).

**Advanced A** for dogs that have earned the RN title but not earned the RA title and is handled by the owner or immediate family member

**Advanced B** For any dog that has earned the RN title.

**Advanced C** For any dog not registered with the CKC but has a Purebred Alternative Login number (PAL Number).

**Excellent A** for dogs that have earned the RA title but not earned the RE title and is handled by the owner or immediate family member.

**Excellent B** For any dog that has earned the RA title.

**Excellent C** For any dog not registered with the CKC but has a Purebred Alternative Login number (PAL Number).

## ENTRY INFORMATION

Dogs must be either registered with the C.K.C., have an Event Registration Number (ERN) or register for a Purebred Alternative Login number (PAL).

All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an ERN. An ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. An ERN may be obtained by contacting the CKC at (416) 675-5511 or Fax (416) 675-6506. A listing fee is payable with Entry Fees for any dog not having an individual Registration Number at closing date.

All dogs that are not registered with the CKC or are considered to be a mix breed must register with their entry for a Purebred Alternative Login Number (PAL).

A Purebred Alternative Login number will be provided to exhibitor with the judging schedule & entry receipt. Exhibitor must apply for their login number with their entry. In order to apply for the login number, the exhibitor must

- a) Complete the entry form
- b) Submit two recent photos of their dog, one front view and one side profile
- c) Photocopy of certificate of spay or neuter
