BRACE CLASS- section 16.6 is open to any 2 dogs of any breed and of either sex that has attained not less than a C.D. title in Canada. It is not necessary that the same person own both dogs, nor that they be of the same breed.

WILD CARD – section 16.5 Novice, Open, Utility

VETERAN'S CLASS(Saturday Trial #1 ONLY)- section 16.8 is open to dogs that have an obedience title and are 7 years and older. Dogs entered in this class must also be entered in any Regular class or for Exhibition Only. All dogs entered in the Veterans Class will receive a Rosette inscribed with their name.

1 Point will be added to the final obedience score for every year that the dog is over 7 years of age.

RULES AND REGULATIONS GOVERNING THESE TRIALS

- ❖ The club reserves the right to remove any person(s) from the show and the show grounds. The Show Superintendent shall have full control of these shows and trials, which are governed by CANADIAN KENNEL CLUB(CKC) rules.
- ❖ A Judge officiating at a trial held under the CKC rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and

obligation of the club to see that this rule is effectively carried out. The Trial chairperson shall promptly investigate and report to the CKC any infringement of this regulation.. The Discipline committee shall have the power to take such action as it deems fit on the report indicating that his rule has been violated.

- ❖ Any person excused by the Show Superintendent or Veterinarian for any reason shall not, compete in any class for any awards for the balance of the shows, trials and or events.
- ❖ The Show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.
- ❖ Dogs must be on the grounds 1 hour prior to their trialing.
- ❖ The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.
- ❖ Exhibitors and handlers will be responsible for their dogs and equipment left at the show grounds.
- ❖ All recreational units will have buckets underneath for their sink drains. Any one found discharging water on the grounds will be removed by order of the Health Department, and may be subject to fine.
- ❖ If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, there is no refund of entry.
- ❖ Dogs must be on leash at all times on the show grounds or within the show building with the exception of the obedience rings.
- ❖ Exhibitors are expected to maintain a clean area. Please be considerate when utilizing the building facilities. No dogs are permitted in the washrooms.
- ❖ The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behavior.
- ❖ The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. The club reserves the right to refuse an individuals entries, for just cause.
- ❖ The club reserves the right of restricting exhibitors space.
- ❖ Fire lanes in all areas will be maintained.
- ❖ Entries which are incomplete after the closing date/time will be void and under no circumstances can changes be made.

Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

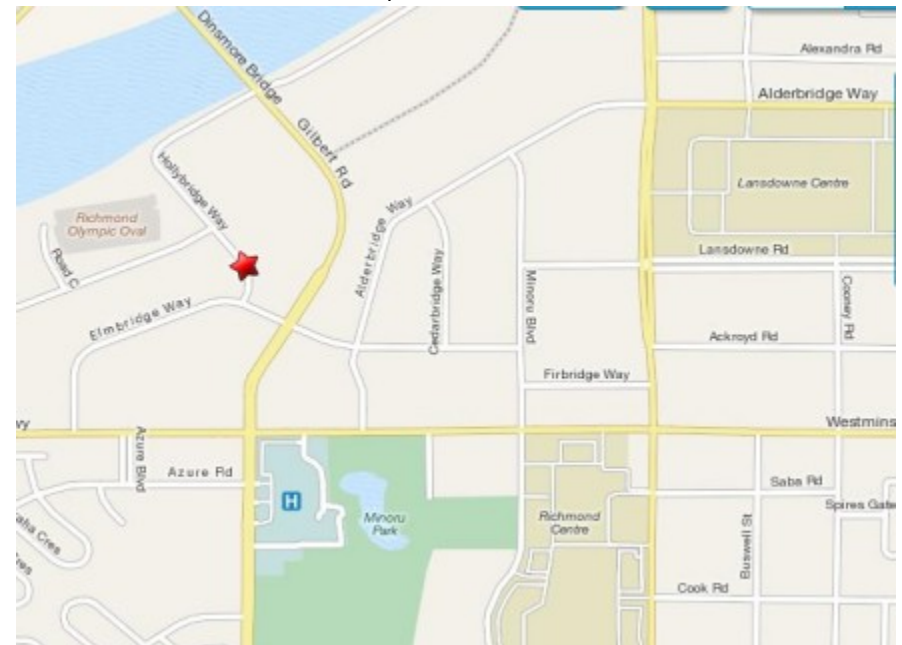
