

General Information

The Agility Committee is in full charge of the Trials. The Show precincts shall consist of 10 ft. around the agility rings. Food and toys are not permitted within 10 ft. of the rings and handlers are not permitted to use whistles, clickers, flexis or other instruments or devices in the ring . Bitches in season $\underline{\mathbf{ARE}\ \mathbf{NOT}}$ permitted anywhere at the trial venue. Dogs must be ON LEASH at all times when outside the ring.

Event Information

Agility rings are outside on grass.

Agility handlers in all classes will be able to walk their course, without their dog prior to the start of the class. Handlers must be ready at the start line when called or risk forfeiting their run. If a dog is not at ringside after it has been called 3 times, it will be marked absent. Please advise us ASAP if you have a conflict and we will accommodate your needs.

There is no shade. Exhibitors are advised to bring shade tents

Agility Obstacles

Obstacle familiarization will be available for Novice classes immediately prior to the first Novice Standard class. Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2014.

Eligibility

To be eligible to compete in these agility trials, a dog must be 18 months of age. Spayed bitches, debarked dogs, and neutered males are eligible to participate.

Bitches in Season

Bitches in season <u>may not compete</u>. When a bitch comes into season after the entry has closed a Veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trial must reach the secretary on or before the start of the trial. A full refund of entry fees and listing fees will be given.

Ribbons/ Trophies

Ribbons will be given for 1st through 4th qualifying scores in all Jump Heights

Move Ups

Move Ups will be allowed. Handler must notify the trial secretary prior to the start of the trial

The owner or handler of the dog must sign the Liability Agreement on the back of the entry form. Incomplete entries will be returned.

Entries will only be accepted if accompanied by correct fees. Courier entries will be accepted if no signature is required.

Refunds

Alterations, substitutions or cancellations of any entry after the closing date is prohibited, except as noted in this premium list. The ONLY exception is bitches in season. Unfortunately we can not refund any entries for injured dogs, that we receive after the closing. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.

If, because of riot, civil disturbance, inclement weather or other acts beyond the control of management, It is impossible to open or complete the show, no refund of entry will be made.

Tendering of NSF cheque is considered as non-payment of fees and is punishable by disciplinary action. NSF cheques will be subject to a \$30.00 fee.

Foreign Exhibitors

Please note that fees are due in <u>Canadian dollars</u>. Discounted cheques will not be accepted. Personal cheques payable in Canadian funds will be accepted. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks and will be returned to you. Please purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

Entries Received

Verification that your entries have been received will be emailed to you when received. PLEASE contact us prior to the early entry date if using the early entry fee or before the closing date if you are paying the regular fee, if you have not received an emailed confirmation receipt from us. Judging schedules will be emailed as soon as possible after the closing date and will be available on our website.

Are you in the correct Class, please note changes?

Selected Class: Any dog eligible to enter an agility trial may enter the Selected Class. Once a dog has been designated as a Selected and entered in this class, the dog cannot revert/transfer back to the Regular class. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one jump height lower then their Regular jump height and get 10% more time then the STC.

Novice is for dogs that have never acquired a CKC agility title in that class. Dogs may continue to compete in Novice once they have acquired that title, but must be moved up once they have a leg in Intermediate in that class.

Excellent is for dogs that have acquired the Intermediate title, but have not yet earned the Agility Excellent title in either Standard or JWW.

Master Excellent (formerly Excellent B) is for dogs that have acquired the Excellent title or the Master Excellent Title. A dog may move up into Master Excellent in only the Standard or JWW class that they have earned an Excellent Title in. A dog only needs to be entered in Master Excellent for the class that he/she has achieved the Excellent title in. ie. A dog can be in Excellent JWW and Master Excellent Standard.

Veteran Class: a dog 7 years of age or older may be entered in the Veterans Class. Once a dog has been designated as a Veteran and entered in this class, the dog cannot revert/transfer back to the Regular or Selected Classes. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one or two jump heights lower then its Regular jump height and this class will get 10% more time then the Regular Standard course time.

For full rules on these classes please refer to the Official CKC Agility rule & regulations.

Non Member Participation Fee \$59.40 + HST

A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.

The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
